



TRAVEL TOURNAMENT AGREEMENT

OPTION 1: _____ (INITIAL) NON-REFUNDABLE DEPOSIT \$100 INCLUDED _____

By signing this form, I have agreed to pay for the **TRAVEL OPTION WITH CHAPERONE** tournament expenses. ALL THE CHARGES FROM THE TOURNAMENT WILL BE SPLIT AMONGST ALL THE PLAYERS PARTICIPATING IN THE TOURNAMENT IN THE FOLLOWING WAY:

1. \$50/day: COACHING FEE: This includes any warm-ups, viewing matches, and match feedback with parents and/or player.
2. \$25/day: CHAPERONE FEE: This is for transporting player to and from tournament, making sure he/she checks in, and any miscellaneous monitoring of player.
3. PLAYER'S HOTEL/GAS FEE: This is a variable fee that depends on the number of players we will need to divide this expense between. For example, if 4 players travel with the coaches and the cost for the players' hotel rooms and gas is a total of \$400 then we will charge each of these 4 players \$100.
4. COACH'S HOTEL/GAS/FOOD/MISC. FEE: This is a variable fee that depends on the number of players we will need to divide this expense between. Miscellaneous fees would include indoor court fees and any other unexpected expense. (Please note: this expense is incurred by both the chaperone and without chaperone option) For example, if 4 players choose chaperone option and 4 players choose without chaperone option but still take coaching and the cost of the coach's hotel, gas, and food is \$400 then all 8 players divide this fee equally for a total of \$50 each.

These fees are then added together at the end of the tournament and charged to your account (less the non-refundable deposit). The more players that opt to choose the travel option, the less the cost will be for each person.

OPTION 2: _____ (INITIAL) NON-REFUNDABLE DEPOSIT \$100 INCLUDED _____

By signing this form, I have agreed to pay for the **TRAVEL OPTION WITHOUT CHAPERONE** tournament expenses. The charges for this option are as follows:

1. \$50/day: COACHING FEE: This includes any warm-ups, viewing matches, and match feedback with parents and/or player.
